

# SAXTEAD PARISH COUNCIL

Minutes of the Annual Parish Council Meeting held on Wednesday 22 May 2012  
at Saxtead School of Dance at 21:00 hours

## Present

Clrs George Cullingford, Graham Ward, Barry Mallion, Lisa Handley, Kate Hoare (*until 10.09pm*). The meeting started at 9.04pm. Before taking their seats Councillors present signed their acceptance of office witnessed by the Clerk.

## 1 Election of Officers

## 4 Confirmation of Minutes

## 5 Public Forum

Cllr Hart (SCC) had sent a written report (email 15/5/12) in which he said would not standing in next year's elections to the county council.

Cllr Davis said there had been a break-in at Saxtead Bottom but nothing taken, apparently. There was discussion of scrap metal collectors, who have been known to go round to the back of properties if no one was in.

## 6 Issues from the Annual Parish Meeting on 26 April 2012

Annual Litter Pick on Sun May 13th Cllr Cullingford thanked Cllr Ward for organising the jackets and BM for doing it and staying to 2.25pm (overall it was 1.45-4.45pm). He was very disappointed that so few turned up out of a total of 220 electors, excluding Foxearth residents. He said an on-going litter pick is done by Mr and Mrs Hartley and by his wife and himself. SCDC did not deliver bags until the Friday but 13 were filled. A parishioner commented to Cllr Cullingford that it was the responsibility of parishioners because they didn't put it there, but someone stopped to thank the litter pickers.

## 11 Saxtead Green management

There is erosion of the area on Marlborough Road where the ice cream van comes. There were seven bollards but now only one. People try to park there off the road and damage the green. Clerk to write to SCDC and Highways. Some more posts are needed, or an alternative solution. No other site has been identified. Clerk

Cllr Cullingford had an email from Peter Ross (SCDC) which said that Pembroke College were undertaking a review of all the lands they owned with a view to mapping them—possibly as a result of Suffolk Wildlife Trust writing to them. Cllr Cullingford had spoken to Mr Ross earlier in the month about stewardship. An area of grass outside Manor Farm has just been cut by Suffolk Coastal District Services, who are not part of SCDC. Mr Ross had said he would enquire about it. The owner may have entered a contract with them to cut the grass. In the past Peter Smith (predecessor of Peter Ross) had advised the owner of Manor Farm what to do. Clerk to write to the owner, and also Highfields and other residents who are contravening the management scheme by cutting grass on the Green in the summer. Also to write to Peter Ross to give him a list of the addresses concerned. The Parish Council feel it should be brought to the attention of the owner of Manor Farm. Clerk

Water in the ditch opposite Old Mill House is not draining and flooded all the way to the pipe under the car park near the digester. When Peter Ross visited there was no water. There are issues of health and safety due to stagnant water. Cllr Cullingford is surprised that no one is complaining. We have to find out why the land is waterlogged. Clerk to pursue with Peter Ross, asking what he is going to do about it and copy to Pembroke College. Clerk

## 12 Wild About Saxtead

Saxtead wildflower identification walks with Stephen Massey on 19 May and 16 June, 2-4pm. There was a good turnout with up to 10 attending on each. Payment of £100 to Stephen Massey for leading the walks was **agreed**. Clerk to find out what happened to the money collected and obtain an invoice via Louisa Yorke. Clerk

## REGULAR BUSINESS

### 17 Clerk's Report

Urgent decisions/actions since the last meeting: none.

The Clerk had mastered the PAYE end of year process.

He had received two copies of the Definitive Rights of Way map from SCDC (1993).

Neighbourhood Watch contact information was now on the website. Cllr Ward said he has thanked Gordon (previous coordinator) for his work, having moved to Framlingham.

### 18 Planning applications and notifications

#### a To note recent determinations:

- **C/12/0261** Highfield, The Green, Saxtead, Woodbridge IP13 9QB: Extension of existing double garage to provide a swimming pool. **Permission granted** 4/4/12 with normal conditions.
- **C/12/0310** Little Green Farm, Worlds End Road IP13 9QY: erection of cart lodge. **Permission granted** 11/4/12 with normal conditions, domestic use only.
- **C12/00049/TCA** Tree Work Notification: Galaxy House, The Green IP13 9QE: T1 Eucalyptus: fell tree next to driveway. T2- T16: remove 15 trees on eastern boundary to allow replacement of fence and replanting. T17-T45 Cypress trees: reduce by one third close to eastern boundary. T46 Leylandii Conifer: reduce by entrance to hedge height. SCDC **raised no objection** (10/5/12). The initial consultation was received by the Parish Council on 5 April and comments were due by 26 April. No objection was raised by the Parish Council.
