8.Clerk Report.

1.Internal Audit.The report was done very quickly and efficiently by Heelis

& Lodge. Due to the delays in the completion of the annual return and therefore the delay of finalising the documents needed by the internal auditor, it was agreed with the external auditor BDO LLP that they should have the documents that were available forwarded to them before the internal auditor had managed to complete his report. The reason for this was because the legal time allowed for a "Conclusion of Audit" is the 30th September and BDO wished to have something lodged before that date. The internal audit was completed on the 18th September and the balance of documents sent to BDO by recorded post on the

18th. My personal thanks were given to Mr. Brown for his efforts in doing the audit so quickly. Needless to say that the audit will be done for year 2014/15 within the allowed dates for completion of each section of the "Annual Return"

2.External Audit. Part explained in 1. the external auditor was getting rather nervous that we would not be able to lodge our documents with them in time for 30th September, however as we were able to provide them with documents before Mr. Brown of Heelis and Lodge had sight of them a major problem was diverted, it would have resulted in Saxtead Parish Council being put on report to the District Council who would have had to investigate our failings to adhere to the strict instructions as laid down by the old Audit Commission. Thankfully with the cooperation of both auditors this was averted, I repeat that needless to say it will not happen again.

3.HMRC/PAYE. Clerk advised all members that the payroll mechanism had been taken over by SALC from Ladywell Accounting. This means that they too will provide the clerk with a bi-monthly payslip and then invoice Saxtead accordingly, at this time I have to yet receive an invoice from them for the work done.

4.Overpayment of invoice. Members were advised by the clerk that an overpayment of salary had been made to the previous clerk of £59.20. for the September 2013 payment. On contacting Mr. Hutt he duly advised the

clerk that there are still expenses to be claimed from Saxtead and that he will make recompense once these have been calculated and provided to the parish council. It was agreed by all members present to give him until the 30.10.14 to settle both items, this proposal was made by Cllr. Beamish and seconded by Cllr. Cullingford.

The chairman mentioned the good work that they do and highlighted the fact that 14 clients from the pc area came to the CAB for advice. It was proposed by the chairman Cllr.
